

Safety comes first in everything we do. The wellbeing of our coworkers, communities and environment is – and will always be – our highest priority. That is why we are proud to report that the safety performance of GEFO Shipping Group is at such a superior level. Our high safety standard is clearly demonstrated by the vessel inspection reports of the various vetting schemes and by the TMSA office audits. It is also evident in our awards from the Green Award Foundation and in the EcoVadis CSR scheme.

In 2022, we successfully continued and even expanded programs such as the Barge Safety Folder, our ISO team and Senior Management Visits campaign (SMV). Our commitment to safety continues.

Member of the PZI

People are at the heart of our success. None of our crew members should be working in unsafe environments or be exposed to any risks. That's why GEFO is a co-founder and strong supporter of PZI (Platform Zero Incidents) and has been a member of the steering committee for several years. A solid interaction between crews and the platform in exchanging near misses and incident learnings ensures steady progress towards an ever–safe working place, preventing injuries and damage to environment, property and life.

Trainings and campaigns

To promote safety on board our ships, we support our employees with trainings and development programs, e-learning and simulation training.

The **BSF (Barge Safety Folder)** for 2022 includes LETs (Learning Engagement Tools) covering important safety trainings:

- Safety Excercises
- LET Safety Barriers
- Emergency Procedure & Notification
- LET First Aid
- Good Spot

- LMRA and Stop Work

Our popular training events **Crew Days (Inland fleet)** were held virtually in 2022 and reached numerous crew members. The **Crew Seminars (Deep sea fleet)** also attracted a lot of interest. See following pages.

The **barge risk assessment program** with quarterly weighing of all operated barges has remained a backbone in our safety strategy. Corrective measures and follow-ups have positively convinced several barge crews to step up and improve. Based on the weak



signals emitted by crews and vessels through our profound risk analysis, Senior Management Visits (SMV) are organized. These visits have proven to be a success.

The **cross-departmental GEFO ISO team** has developed into an auditor team with a member – the jumper – per division within GEFO. Cross-learning is our most important goal, as this supports continuous improvement by analyzing the processes of the other divisions/departments. Giving us a clear overview of easy manageable processes and supporting newcomers in each department efficiently understanding their roles and responsibilities.

Senior Management Visits

We see teamwork as one of the most important foundations of our success. Hence also our hashtag #weareGEFO, we work as ONE team towards a zero industry. To strengthen the bond between our crews on board the vessels with the management staff, we have launched the Senior Management Visits (SMV) and SMV light campaigns. By visiting the workplace, the "hometurf" of the employees on board, we show our support and commitment and ensure that they can work safely in all conditions.

The **Senior Management Visits** are carried out by the General Management & Management Team and are predominantly driven by weak signals on board. **SMV Light Visits** are carried out by individual members of the commercial and operational departments. Further ship visits are made by **Technical department and HSSEQ.** Topics discussed include near misses, safety awareness, wellbeing, training on board (barge safety folder) and ad hoc topics. Just as important, however, is the appreciation of the hard work on board: ONE team, on board and ashore, working together towards safety and operational excellence!

Virtual Crew Days 2022 – for more safety on board.

To promote safety on board our ships, we support our employees with regular training events, the popular Captain's Days. After pandemic-related cancellations, we are now holding the events virtually. The big advantage: not only the captains but all crew members can be reached. Consequently, we have renamed the traditional event: Welcome to the new Crew Days!

Exciting presentations and discussions

On six dates in 2022, the crews of our Inland fleets were invited to our online training events, organized out of Studio Schuttevaer/ ProMedia Studios.


Following the opening statement by GEFO Managing Director Sven von Appen, the focus was on important safety and operational topics.


Topics of the safety videos

- Defensive navigation and the use of ECDIS
- Vetting process and crew conduct
- Degassing legislation and real world
- Tank loading and flushing
- Planned maintenance

During broadcasting of the pre-produced video fragments, the participants were able to ask questions via a chat box, which were then asked to the panel of GEFO HSSEQ Specialists by Rene Quist (Editor in chief of Schuttevaer).







The response was excellent

The opportunity for interactivity was well used and resulted in a total of 400 chat messages with relevant questions. Attendance was also high, with a total of 280 captains, helmsmen, ABs and students participating (over 30% more than 2019) and providing excellent feedback. The videos are still available as e-learnings for the crews.

This year, we will go one step further and organize four Crew Days both with physical presence and livestreams within each event. This way, we enable more interpersonal contacts and reach even more crew members.

Crew seminars for the Deep sea fleet

We also held two-day crew seminars in Gdynia and Malmö for our Deep sea fleet crews in 2022. Dr. Professor Manuel of WMU Malmö lectured mental health for our seafarers. Mental health was an important topic during the Covid-19 Pandemic, and remains underrated across the maritime workforce.

It has thus been decided that not only the Ship's staff and officers should be addressed, but the ratings equally well.

The Near Miss Report – step by step towards the "zero accidents" goal.

The health of all GEFO employees as well as their safety is the utmost goal; strive for zero is not just a slogan. In 2022, the KPI for LTIF (Lost Time Injury Frequency) was 0,84, but with a significantly increased number of exposure hours. The TRCF (Total recordable case frequency) went down to 2,09 compared to 2,35 in 2021. The target for the next years remains unchanged: 0 accidents, thus a total of 0 per 1.000.000 working hours shall be achieved! No employee of GEFO Shipping Group should suffer any harm during their work, respectively recreational activities on board our vessels.

The GEFO Shipping Group Deep sea vessels reported in total 880 "near misses" (including good spots) in 2022. This is again a good result, taking into account that the fleet was growing only moderate in 2022. Therefore the growing amount of reports reflects a very good acceptance within our fleet.

Aim of creating so-called good spot reports was to enable reporting of positive examples of good working practice/best practice. For 2022, the good spots reflected a share of 9% of the total amount of reports – an excellent result.

In total, 979 NM (near misses) have been reported by our crews on board the Inland fleets, on about 118 (average) vessels throughout the year. The fleet is split up in GEFO Gas, UNITAS (chemicals) and GEFO Mineral Oil and Light Chemicals and can furthermore be differentiated in owned and private barges. Nevertheless, is the safety and quality management system on board all vessels equal, as well as reporting system and targets.


The amount of NM has been found close to the initial target KPI of 1 NM per month per vessel per month per vessel, herewith slowly moving away from the actual KPI but strongly improving on qualitative content. For 2022, the KPI achievement was 0,75 with 979 NM out of our operated fleet of 118 vessels. GEFO GAS was the high flyer when this KPI is considered by fleet, with 11,6 NM per vessel on average over the year, followed by BARGING with 9,1 per vessel.

Both within the Inland fleets and the Deep sea fleet, assessments of the navigational performance are conducted. Data collected are circulated to all crew members by means of circular letters. More importantly, these assessments are initiated based on incidents and near misses in the past. This is a strong and effective tool to measure the navigational standard as well as training our crew members on the job.

Inspections and Audits – excellent results in all parts of the fleet.

Safety inspections

GEFO Shipping Group always strives to improve the safety of its vessels. Therefore, GEFO Shipping Group regularly participates in various safety initiatives. With our inspection reports, we also contribute to the continuous improvement of safety and quality in the maritime industry all over the world.

- On average 2,69 observations were noted during SIRE inspections (3,62 in 2021)
- On average 4,46 observations were noted during CDI inspections (4,80 in 2021).

These excellent results were achieved by solid teams in our existing and very well managed fleet. Several inspectors made a point in 2022 that GEFO is one of the best (if not THE BEST) chemical tanker operator in Europe!

TMSA reviews and audits

The company passed **TMSA** and management reviews carried out by our customers. The submission GEFO has laid down on the basis of the self reflection of 2022, shows a consistent score of 3 in all elements. This self assessment has been confirmed by both auditing companies independently of one another. Both TMSA reviews were completed without major non-conformity, respectively high risk findings and the HSSEQ review was concluded successfully as well.

The **ISM annual DoC audit** for Cyprus was carried out by DNV GL and passed without any non-conformity. An additional DoC audit was conducted in Hamburg.



External inspection programs

GEFO Shipping Group participates in several external inspection programs. In addition, our internal audits ensure the high quality and safety standards of our vessels.

- The inspection regime under OCIMF has now ran in its second year. As was to be expected, a better and more profound knowledge of the inspectors has led to a rise of observations. This can also be stated on average in our fleet, with a subtle observation rise from 3,63 to 4,05. GEFO has joined the working group (iBEQ OCIMF) preparing a new barge inspection questionnaire (BIQ) and barge particulars questionnaire (BPQ) as a representative for the inland barging industry.
- Many Internal audits were scheduled and conducted in view of the ISO9001:2015 Audit schedule. The outcome has proven that the company has matured but still has a development laid out into the future. That is of course what continuous improvement is all about.
- In 2022, five different companies invited themselves over to conduct TMSA Office Reviews in Duisburg. With one exception, every audit lasted for two consecutive days and was conducted by two auditors. The overall score laid down in the 2022 TMSA submission reflects a solid 2 across all important elements, where often even the third level has been accomplished. A continuous improvement is stated by all auditors, and the consistent and hard work of the HSSEQ and Technical departments is largely credited.



Health and contentment: We care for our staff.

Our more than 1.600 employees on board and ashore work as ONE team (#weareGEFO) and thus ensure that our vessels are operated safely and efficiently. That is why it is important to us that officers and crews find optimal working conditions. A healthy working environment in which employees feel comfortable is therefore very close to our hearts.

Contentment in the team guarantees continuity in ship operations and thus a safe, qualitative and fast delivery. GEFO Shipping Group is considered an excellent and reliable employer, and this is reflected in our high retention rates.

Our HSSEQ/Technical Department has been certified, as well as numerous vessels. The Green Award can only be obtained by vessels that go above and beyond the industry standards in terms of safety, quality, and environmental performance. It is one of the most important quality marks in the shipping industry.

GEFO Shipping Group's contribution to low-emission shipping.

The maritime industry is vital to the global economy: It accounts for about 90% of the volume of global trade. Thus, the demands on shipping to reduce global greenhouse gas emission in line with the goals of the Paris Agreement are intensifying.

GEFO Shipping Group is well on the way to achieving this. Thanks to the introduction of new technologies and innovative propulsion systems, we are gradually reducing the fleet's pollutant emissions.

In 2022, emissions were higher because we had more vessels in operation. Almost all of our ships were heavily utilized throughout the year and therefore produced more CO₂-emissions.



Climate neutrality by 2045

Besides the European Commission who strives for climate neutrality by 2050, Germany has already decided on climate neutrality by 2045 with the last amendment to the Climate Change Act. GEFO Shipping Group strongly supports this goal. Thus we are highly involved in own and customer driven initiatives to realize alternative engine and propulsion systems and contribute to the German goal of climate neutrality by 2045.



The future of shipping, developed by GEFO: the new Canaletto.

In December 2022, GEFO launched the newbuilding Canaletto, a highly innovative tanker optimized for extreme low-water situations. With a whole range of innovative features, the multipurpose barge makes a significant contribution to reducing pollutant emissions and strengthening the inland waterway as a mode of transport.

Innovative and eco-friendly

The Canaletto is equipped with a diesel–electric hybrid propulsion system whose generators are well below the latest EU Stage V emissions standard. They undercut the EU Stage V emission standard for oxides by more than $50\,\%$ and for particulate matter by more than $70\,\%$.

In addition, the specially developed water-cooled marine batteries enable all-electric sailing at times as well as complete power supply when at berth. Emissions are avoided entirely!

Our answer to climate change

Low water periods are expected to become more frequent in the near future. That is why we have developed a new ship design. At critical points, such as the Middle and Upper Rhine, the Canaletto can still maneuver safely with a cargo of 500 tons even at a level of 30 centimeters at Kaub gauging station. Under these conditions the Canaletto carries about 50% more than other tankers with comparable dimensions. This makes it the best low-water carrier on the Rhine.

Other technical innovations, such as an early warning system to protect against bridge collisions, contribute to increased safety.

Sustainable investments in the GEFO fleet.

While vessels transport 90% of all goods worldwide, they cause only 2% of manmade $\mathrm{CO_2}$ -emissions. Nevertheless, shipping must of course do its part to reduce greenhouse gas emissions in order to meet the climate targets of the Paris Agreement and stop global warming.

Our 400 Mio. Euro investment program reflects our engagement for climate and environment. "Green" propulsion systems and emissions reduction are top priorities for all newbuildings. In both the sea-going shipping and inland water transportation sectors we are investing in a sustainable future. The investment program will be completed in 2024. But the fleet will also be steadily renewed in the coming years.

Reduction in pollutant emissions

The partial renewal of the fleet is expected to achieve fuel savings of up to 30 % and a reduction in pollutant emissions to the same extent, also up to 30 %.

Particularly in the inland tanker segment, the use of engines and exhaust systems that comply with the new EU Stage V standard, emissions of hydrocarbons will be reduced by 81%, nitrogen oxides by 97% and particulate matter by 95%.

In accordance with the Paris Agreement GEFO is endeavoring to make its ships carbon-neutral by 2045. The current modernization of the fleet has successfully initiated the process towards a climate-neutral fleet and will be consistently pursued over the next two decades.

We invest in new ideas.

GEFO is participating in many projects within shipping and sustainability, keeping a finger on the racing pulse of developments around us.

Here we would like to introduce you to some of our new projects.

The CO₂ transportation projects

GEFO Shipping Group is involved in the early stages of several projects enabling the transportation of CO_2 on barges and seagoing vessels as part of the required infrastructure for current and future Carbon Capture and Storage (CCS) projects from the entire supply chain of industrial sites up to special gas fields in the North Sea.

Green shipping initiatives

GEFO is participating in several initiatives and projects with regulatory institutions and foremost with major clients in the oil and chemical industry regarding "green shipping". These projects involve the use of green fuels such as green methanol, ammonia or hydrogen for alternative propulsion systems of inland barges or deep sea vessels and the role of a logistics service provider to transport these new alternative energy sources within the whole European inland barging and short-sea region.

The Flettner Rotor project

The quest for saving fossil fuels poses huge challenges for us as chemical tanker operator on short sea trades. One step beyond switching to alternative fuels, is installing aids to mechanical propulsion. One project which has been largely brought to a finalized plan, is the installation of a Flettner Rotor on one of our larger deep sea vessels. It will deliver additional thrust to the vessel thus reducing burning of traditional fossil fuel by as much as 15 %.

Reducing plastic bottles on board

On board, people mostly drink water from single-use plastic bottles. This form of water supply is costly and environmentally harmful, because PET takes up to 450 years to dissolve. Therefore, we are working on the feasibility to implement and install drinking water filling stations on the deep sea vessels to avoid PET bottles and reduce the environmental footprint.

More safety: The launch of the new digitization campaign

In 2022, we launched a comprehensive and innovative IT change process across the GEFO Shipping Group to align with current challenges and address future innovation initiatives. The GEFO digitization campaign includes the following steps:

- Roll-out in 2022 of a centralized GEFO IT platform to integrate all commercial departments as well as HSSEQ, Technical and Crewing departments on one IT platform.
- Introduction of **new GEFO IT standards** (hardware and software) within GEFO's own Inland fleet together with integration on the central GEFO IT platform for digitization across the complete GEFO Shipping Group.

These steps will simplify processes and make it easier for crews to work on board. In addition, we are setting new industry standards in automated IT chartering tools which will **increase safety in the shipping industry**:

- · Automated hazardous product information based on government regulations combined with technical vessel information.
- IT integration for industry reporting schemes such as automated direct communication with European safety institutions.

With the new system, we are taking account of the increased importance of **cyber security**. In recent months, attacks on the IT structure of companies in the so-called critical infrastructure have been on the rise. Our new IT structure is an important component of GEFO's cyber security strategy. Training is another point when it comes to cyber security. Among other things, we train our employees how to identify dangerous phishing emails.





Engagement and collaboration.

For us as a tanker owner and operator it is a vital part of our safety culture to develop training scenarios with a real expert organization like WMU, not only with regard to our demanding customers, but also with regard to the safety of our crew and environment. The cooperation with WMU is in all respects beneficial and has improved our efforts towards accident prevention as well as the resilience and mental health of our crews.

Successfull collaboration with the WMU.



A good, motivated crew is probably the most fundamental keystone for sustainable success. Training in our ever-evolving high-tech industry is of the utmost importance. And protecting the health of our personnel on board is also a top priority for GEFO Shipping Group. We address both topics in collaboration with the World Maritime University (WMU) in Malmö/Sweden. The WMU is the global center of excellence for postgraduate maritime education, research and capacity building, recognized by the IMO and the United Nations General Assembly.

Attending courses on seafarer health and well-being

The cooperation with the WMU, which had started back in 2014, has continued also in 2022. In September, a group of 25 professionals from GEFO participated in an customized **Executive and Professional Development Course** (EPDC) on seafarer health and well-being, delivered by Dr. Michael Manuel, WMU Professor.

Specific topics addressed included workload stress, social isolation, alcohol & drug issues, interrelation between corporate practices and individual perceptions, and characteristics on health and well-being. It has thus been decided that not only the Ship's staff and officers should be addressed, but the ratings equally well. For 2023, a WMU seminar for the ratings has been organized.

WMU President Dr. Cleopatra Doumbia-Henry emphasizes the close relationship between WMU and GEFO: "The WMU is proud to have a great relationship with GEFO. The company's commitment to employee education and development through WMU is a testament to their dedication to excellence and innovation in the maritime industry".

Mental training strengthens the resilience

To empower the well-being of our maritime workforce, we conduct training sessions. **GEFO's mental training initiative** strengthens the resilience of crew members by improving their situtional awareness and mental preparedness.

Through the training, crew members gain a deep understanding for the various causes that often trigger dangerous situations and internalise action plans for dealing with them in the most optimal way. As a result, the individual "toolbox" grows with every training session and with it the probability of having the right tool at hand for solving a specific problem. The applied methods enhance the stress coping and decision–making skills of each individual but also of the crew as an operational unit.

Topics discussed during our training sessions include stressors at sea, social isolation, possible conflicts and prevention of the same, as well as resolution, and optimizing wellbeing and mental health onboard. Putting the before said into an applicable context for each crew member, strengthens the ability to deal with stressors and leads to a high level of resilience for each individual.


